Church Hall

The church hall located on Elvaston Lane is used by various groups. The regular hirers are:

Derby Dance on the 2nd and 4th Monday of the month 7-30 to 9-30 Yoga 6-7 every Tuesday

Brownies and Guides every Wednesday evening

Slimming World 5-30, 7pm to 9 every Thursday

Martial Arts 10-11 every Saturday

Apostolic Church by arrangement some Friday mornings and some Sundays Private parties by arrangement – we have had a lot less hirers this past year. ACT Foodbank is located in the Annex and is used year round. Donations received on Tuesday 10-12.

During the year we lost 2 regular hirers – Slimming with Dianne and Festival Church - but gained 2 small hires in a regular Yoga class and a Self Defence class.

With effect from 1st October the electricity rates increased by 126% so we have had to, reluctantly, increase the hire charges in 2023 to try and mitigate our losses. However, we are now in danger of not being able to attract new hirers particularly the casual one-off bookings

2023 will be very challenging for the Hall and unless we can substantially increase the number of hires the sustainability of the Hall does not look favourable.

Year End Financial Report Alvaston PCC

GENERAL FUND

Our total income at £38,248 was an increase on previous year of 9% and total expenditure at £36,130 a reduction of 2% resulting in a profit over the year of £2,117 compared with previous year's deficit of -£1,706. We had budgeted for a deficit of -£4,270. At the end of the year the general fund stood at £11,537.

Voluntary Income, from regular donations and collections, at £24,970 increased by £1,827 (+8%) on previous year and was up on budget by £2,560 (+11%).

Other Income at £13,277 increased by £1,212 (+10%) on previous year which was mainly due to the increase in the level of PCC fees (funerals etc) and was up on budget by £1,562 (+13%).

Total Income increased on last year by £3,039 and was up on budget by £4,123.

Church and Ministry Expenditure at £10,970 increased by £656 from previous year but was £2,630 below budget. Significant underspend against budget on minor repairs and maintenance and the churchyard were offset by increases in the cost of gas and electric during the later part of the year.

Other Expenditure at £4,140 was similar to previous year but was up on budget by £364. Mission giving of £2,310 was paid to various local and national causes during the year.

Common Fund paid to the Diocese was £21,000, which was the same as previous year and in accordance with budget. The total paid was 84% of that requested by the Diocese.

Total Expenditure in general fund was £36,915 being £3,018 down on last year and down on budget by £2,400.

DEVELOPMENT FUND

At the end of the year the Development fund stood at £3,527, which was a net increase through the year of £1,450.

Income totalled £1,967 including Christmas fair proceeds of £1,271.

Expenditure was £517 which was all attributable to Christmas publicity costs

RESTRICTED RECEIPTS

At year end an amount of £5,305 was held of which £2,490 is attributable to the Food Bank , £2,000 grant attributable to a Hardship fund, £631grant for the Warm Welcome initiative. Other small amounts will be paid out early in 2023.

CHURCH HALL

Income from the Hall was £11,774 an increase of £1,132 on previous year after a year when most of our regular hirers returned together with 2 new regular hirers who started during the year. Unfortunately, by the end of the year three regular hirers had decided to leave. Previous year income had included £4,000 of covid grants received which ,obviously, was not repeated in 2022.

Due to the very large increase in electricity cost from October it was reluctantly decided that rents would have to increase by 25% and our existing hirers were informed that this would be with effect from 1 January 2023.

Expenditure for the year totalled £11,829 which was a slight increase on previous year of £187. The Hall maintained its valuable contribution to the common fund at £3,600. As a result of the above Hall made a loss for the year of £53.

FUNDS BALANCE SHEET

Total funds held at year end, including Church hall, stood at £26,916 represented by £14,243 held in current accounts, £11,307 in reserve accounts and £1,366 in cash. £10,074 of the total funds is held in restricted funds.

Churchyard

It doesn't seem 5minutes since the last annual report on the Churchyard.

We are still asking people to comply with the Churchyard Regulations, this is mainly to improve access and maintenance but more importantly to minimise the risk of injury to visitors and volunteers.

Maintenance of graves continues, and we have been fortunate during 2021 to have donations of topsoil and other materials to allow this to progress and fortunately part of this is still available into 2023.

The additional waste bins provided by Derby City Council have proved very beneficial but sadly we are still having to monitor them to ensure that the correct materials are in the correct bins.

As 2021 came to an end work started on managing the regrowth on the trees that were pollarded earlier in the year and this will continue into the spring of 2023.

We continue to manage the regrowth on the trees and be vigilant for disease and decay through into the autumn.

This ensures that the risk of injury to our visitors and volunteers is kept to a minimum.

This work is part of a rolling five year programme to maintain and manage our tree stocks.

The planted area behind the Memorial Garden has been cleared, this was due to the area being used for toilet facilities, once settlement has been completed this area will be seeded with the long term hope that it can be used as part of the Memorial Garden.

Also a yew tree was removed form the east end of the churchyard, this in turn created six additional burial plots for parishioners each capable of multiple interments.

We continue to look for ways to extend the life of the churchyard for burials as we have no problem in meeting requests for the interment of cremated remains.

Sadly, 2022 did not see any significant progress on any of out projects, funding again being the main issue.

In 2023, when the weather permits, it is hoped to improve the paving from the meeting room towards the Memorial Garden and also across the east end of Church.

Ongoing work is being done to deal with pot holes in the car park and we are actively looking for the best method for long term repairs, ideally this would be to provide a kerbed edge to the west and north sides of the car park and to lay tarmac over the existing limestone base potentially this could cost some £35000+.

We are also look at option to improve parking arrangements.

The Churchyard remains open for full burials and the interment of cremated remains but the space available for new full burials is still limited with the availability of new graves for full burials expected to last for only about three more years.

Settlement of the existing graves remains a challenge and regular inspections are carried out to identify problems with not only settlement, but also memorials, edgings and other placements that are not permitted under Church Regulations or create a potential for injury to visitors and volunteers as mentioned earlier.

The problem of the disposal of litter and waste is still with us, with such materials (ranging from grass cuttings, dead flowers, to kerbs and chippings) being thrown into the hedge line and down the embankments, in some cases covering existing graves in the lower Churchyard. But there has been some improvement.

This of course creates additional work to maintain the churchyard.

Visitors are encouraged to use the wheelie bins located in the car park or to take their waste home for recycling if preferred.

Visitors to the Churchyard have remained high, both families of loved ones and casual visitors which is very encouraging.

Once again may I thank those visitors who "do their bit" to help with the maintenance of the Churchyard, a number that appears to have again increased over the year.

It is hoped that 2023 will allow more time to deal with the maintenance issues (weather and volunteers permitting) especially mowing, maintenance of the car park, footpaths and our other fences
